Explanation of Responses:

1. The number of shares to be sold, as reported in this Form 4, represents 34,147,243 shares to be sold by TPG Semi and 15,037,029 shares to be sold by ON Holdings (each as defined below), pursuant to an underwriting agreement dated May 7, 2007. The transactions reported herein will be consummated on May 11, 2007.

2. The price reported herein represents the public offering price of \$11.05 per share less the underwriter's discount of \$0.005 per share.

3. TPG Advisors II, Inc. (the "Reporting Person") is the general partner of TPG GenPar II, L.P., which is the general partner of each of TPG Partners II, L.P. ("Partners II"), TPG Parallel II, L.P. ("Parallel II"), TPG Investors II, L.P. ("Investors II") and TPG 1999 Equity II, L.P. ("Equity II" and, together with Partners II, Parallel II and Investors II, the "TPG Funds"), which in turn are the sole members of each of TPG Semiconductor Holdings LLC ("TPG Semi") and TPG ON Holdings LLC ("ON Holdings", and together with TPG Semi, the "ON Semi Funds").

4. Because of the Reporting Person's relationship to the TPG Funds and the ON Semi Funds, the Reporting Person may be deemed to beneficially own the securities directly owned by the ON Semi Funds. The Reporting Person may also be deemed to beneficially own such securities to the extent of the greater of its direct or indirect pecuniary interest in the profits or capital accounts of the ON Semi Funds. Pursuant to Rule 16a-1(a)(4) under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), this filing shall not be deemed an admission that the Reporting Person is, for purposes of Section 16 of the Exchange Act or otherwise, the beneficial owner of any securities beneficially owned in excess of such amount.

5. In addition, David Bonderman and James G. Coulter (the "Reporting Person Shareholders") are officers, directors and sole shareholders of the Reporting Person, and therefore may be deemed to beneficially own the securities beneficially owned by the Reporting Person. Pursuant to Rule 16a-1(a)(4) under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), this filing shall not be deemed an admission that the Reporting Person Shareholders are, for purposes of Section 16 of the Exchange Act or otherwise, the beneficial owners of any securities beneficially owned in excess of such amount.
