- On February 26, 2009, the Board of Directors of the Issuer awarded this restricted stock to the Reporting Person under the Issuer's 2000 Stock Incentive Plan, with an effective grant date of March 2, 2009, with immediate vesting and release of restrictions upon the grant date, subject to the terms and conditions of the Issuer's 2000 Stock Incentive Plan and the relevant award agreement. This award may only be settled in shares of the Issuer's common stock upon vesting/release. This award was for no consideration other than service as a member of the Issuer's Board.
- On February 26, 2009, the Board of Directors granted this stock option to the Reporting Person under the Issuer's 2000 Stock Incentive Plan, with an effective grant date of March 2, 2009. Generally, the stock option will vest one-third on each of the first through the third anniversaries of the grant date, subject to the terms and conditions of the plan and the related stock option agreement. The exercise price is the closing price on the grant date. The grant was for no consideration other than service as an executive officer of the Issuer.
