Explanation of Responses:

Generally, the grant provides for vesting of approximately 8.4% on the grant date, and approximately pro rata vesting for each subsequent 6 month period. The grant was fully vested as of the date of this transaction. The exercise price was the closing price on the grant date.
- These transactions were made pursuant to the Reporting Person's existing Rule 10b5-1 plan. Option was originally granted effective February 5, 2003 under the Issuer's Stock Incentive Plan. Generally, the grant provides for pro rata vesting of 25% per year on each of the first through fourth anniversaries of the grant date. The exercise price was the closing price on the grant date.
