**Explanation of Responses:**

- This transaction reports the acquisition, effective October 30, 2008, of 36,000 shares of common stock resulting from the vesting of an equal number of units due to the attainment of tranche 1 performance goals under an earlier PBR SU Award (as defined below). The Compensation Committee/Board of the Issuer (Committee) originally awarded 120,000 performance based restricted stock units ("PBR SU Award") to the Reporting Person with an effective grant date of June 2, 2008, subject to the Issuers 2000 Stock Incentive Plan (Plan) and a related award agreement. Under the award agreement, the PBR SUs vest in three tranches based on the achievement of a range of specified total consolidated revenues and related gross margins prior to the end of the fiscal quarter in which the 3rd anniversary of the grant date falls.
- This transaction reports the disposition of shares of common stock withheld by the Issuer in connection with the vesting of the PBR SU Award explained in (1) above. This withholding is pursuant to the related grant agreement in order to satisfy the Reporting Person's tax obligations due upon the vesting of the units. The Issuer will pay the taxes on behalf of the Reporting Person.
