Explanation of Responses:

- This transaction reports the acquisition, effective August 12, 2008, of 35,000 shares of common stock resulting from the vesting of an equal number of units due to the attainment of tranche 1 performance goals under an earlier PBRUS Award (as defined below). The Compensation Committee/Board of the Issuer ("Committee") originally awarded 145,000 performance based restricted stock units ("PBRUS Award") to the Reporting Person with an effective grant date of October 1, 2007, subject to the Issuer's 2000 Stock Incentive Plan ("Plan") and a related award agreement. Under the award agreement, the PBRUSs vest in three tranches based on the achievement of a range of specified product revenues and related gross margins prior to the end of the fiscal quarter in which the 3rd anniversary of the grant date falls.
- This transaction reports the disposition of shares of common stock withheld by the Issuer in connection with the vesting of the PBRUS Award explained in (1) above. This withholding is pursuant to the related grant agreement in order to satisfy the Reporting Person's tax obligations due upon the vesting of the units. The Issuer will pay the taxes on behalf of the Reporting Person.
